## **Bookkeeper's Summary Report**

Period Ending June 30, 2022, Cash Basis

### Lodging Tax Report – Town of Carbondale

- Lodging Tax for April 2022 is \$11,910: a 37% increase over April 2021. April 2022 lodging tax is received by TCC in June 2022.
- Lodging Tax for May 2022 (\$12,487) is received by TCC in July 2022, so does not appear on June 2022 financial statements
- 2021 Total Lodging Tax (January-December 2021) is \$165,473

## YTD P&L Actuals June 30, 2022 (Blue Column)

- Lodging Tax Income on P&L: \$87,515 Actual vs Budget \$64,000
- June 2022 Lodging Tax Income on P&L (\$11,910) is comprised of lodging tax collected in April 2022
- Total Income: \$87,766 Actual vs Budget \$64,386
- Net Ordinary Operating Income: \$24,940 Actual vs YTD Budget -\$4,235
- Net Income including Other Income & Other Expense: \$45,570 vs YTD Budget \$22,765
- Reserves are budgeted to be funded by an additional \$20,000 in 2022; Opp Fund is budgeted to be funded by \$15,000 at the end of 2022

## Balance Sheet as of June 30, 2022 (Blue Column)

- The Operating Checking Account balance is \$127,451 compared to \$106,945 at 06/30/2021
- NOTE: the surplus cash in the Operating Checking Account is intended to be used to cover the 2022 budget deficit (this was reflected in the 2022 budget approval)
- Money Market cash account balance (Opportunity & Reserve Funds combined) is \$114,842 compared to \$73,333 at 06/30/2021
- Reserve Fund Equity account is \$87,986 (includes MM cash account interest earnings)
- Opportunity Fund Equity account is now at \$26,850; Opportunity Fund is budgeted to be fully used in 2022; Opp Fund is also budgeted to be funded by \$15,000 at the end of 2022
- Reserve Fund at 06/30/2022 (\$87,986) covers ~63%, or about 7.5 months, of 2022 Operating Expenses; Reserves are budgeted to be funded by an additional \$20,000 in 2022

### Additional discussion:

• Renee shared that lodging number for July collections to date are \$18,198.01 which is a 7.1% increase from 2021.

## 6. Town of Carbondale Updates

- Lodging Tax Increase discussion at BOT meeting. 1%, 2%, 3% options. BOT decided to go against the lodging tax increase, but instead a 6% STR tax increase.
- Marty: Hard to compare lodging tax for the last few years, you need to compare to 2018. We require all STR to have a license. Different requirements for owner occupied and non-owner-occupied units. Town ordinances on how many people can be in each bedroom. Compared to other places in Colorado. 6% was unanimously approved (will be on the ballot in November), still less than many other communities across the country. Didn't want two different local tax issues on the ballot at the same time. Address lodging tax another time. Communities around us are raising
- Gateway RV Park: Collect lodging tax
- Sarah-Jane: What does the community want to see for the use of the increase tax. There are other ways to increase our funding, instead of lodging tax increase
