Tourism Council of Carbondale Bookkeeper's Summary Report

Period Ending May 31, 2022, Cash Basis

Lodging Tax Report – Town of Carbondale

- Lodging Tax for March 2022 is \$16,848: a 43% increase over March 2021. March 2022 lodging tax is received by TCC in May 2022.
- Lodging Tax for April 2022 (\$11,910) is received by TCC in June 2022, so does not appear on May 2022 financial statements
- 2021 Total Lodging Tax (January-December 2021) is \$165,473

YTD P&L Actuals May 31, 2022 (Blue Column)

- Lodging Tax Income on P&L: \$75,605 Actual vs Budget \$53,333
- May 2022 Lodging Tax Income on P&L (\$16,848) is comprised of lodging tax collected in March 2022
- Total Income: \$75,678 Actual vs Budget \$53,530
- Net Ordinary Operating Income: \$22,188 Actual vs YTD Budget -\$7,187
- Net Income including Other Income & Other Expense: \$43,794 vs YTD Budget \$33,312
- Reserves are budgeted to be funded by an additional \$20,000 in 2022; Opp Fund is budgeted to be funded by \$15,000 at the end of 2022

Balance Sheet as of May 31, 2022 (Blue Column)

- The Operating Checking Account balance is \$125,676 compared to \$112,931 at 05/31/2021
- NOTE: the surplus cash in the Operating Checking Account is intended to be used to cover the 2022 budget deficit (this was reflected in the 2022 budget approval)
- Money Market cash account balance (Opportunity & Reserve Funds <u>combined</u>) is \$114,841 compared to \$73,332 at 05/31/2021
- Reserve Fund Equity account is \$87,986 (includes MM cash account interest earnings)
- Opportunity Fund <u>Equity</u> account is now at \$26,850; Opportunity Fund is budgeted to be fully used in 2022; Opp Fund is also budgeted to be funded by \$15,000 at the end of 2022
- Reserve Fund at 05/31/2022 (\$87,986) covers ~63%, or about 7.5 months, of 2022 Operating Expenses; Reserves are budgeted to be funded by an additional \$20,000 in 2022
